



ARTICLE GUIDELINES FOR SUBMISSION TO THE BANKRUPTCY BAR ASSOCIATION FOR THE DISTRICT OF MARYLAND

- **Title:** The title should reflect the content of article.
- **Topic:** The subject of the article should be bankruptcy related.
- **Recommended Length:** 200-2500 words including notes.
- **Citations:** Citations should be in a format that would be appropriate for pleadings. Please use endnotes instead of footnotes.
- **Font:** The font must be Times New Roman 12pt.
- **Byline of author(s):** Please provide a brief byline for your article, containing the name(s) of the authors, name(s) of firms, and email address.
- **Editing:** The BBA may edit the article for space constraints and style. You will have the opportunity to approve the edited version before it is published.
- **Submission:** Please submit your article, along with an executed Publication Agreement (found on the BBA website) by email to the Articles Editor, Lori Simpson lsimpson@lsimpsonlaw.com. The article should be submitted in Microsoft Word. Please call Lori at (410) 468-0054 with any questions.

CONTRIBUTION TO A COLLECTIVE WORK — PERIODICAL**

In addition, you assign the nonexclusive worldwide right to use the

work to promote and publicize BBA or its publications, including the right to use your name and likeness and biographical data in such promotions. If published, you will be identified as the author of the Work, or co-author if applicable.

Warranty: You warrant that the Work is original with you, that it is not subject to any existing copyright and that you have authority to grant the rights in this Agreement; that its publication will not libel anyone or infringe on or invade the rights of others and will not cause harm to anyone; that you have full power to make this agreement, and that the Work has not been published elsewhere in whole or in part (except as may be set out in a rider attached herewith). Should the Work contain any material that requires written permission for inclusion in the Work, you agree to obtain such permission from the copyright proprietor consistent with this Agreement.

You acknowledge that execution of this agreement does not obligate BBA to publish your work, and that BBA shall have complete and sole discretion to edit all manuscripts submitted for publication. By executing this agreement, you agree to withdraw duplicate submissions or substantially similar versions of this Work from publishers other than BBA, until such time as BBA has published this Work and has granted reprint permission, or until BBA notifies you of its decision not to publish this Work.
